# CCSC: CP Steering Committee Meeting Minutes Saturday, January 7, 2012 Ozarks Technical College Springfield, MO

- 1) Welcome George Gibeau
- 2) Regional Steering Board Meeting Scott Sigman, Regional Representative
  - 1. Approval of minutes from August 6th, 2011
    - Scott Bell presented the minutes and they were approved.
  - 2. 2013 Avila College, updates and approval of the 2013 budget. (Ron McCleary)
    - We discussed allocating money for service award plaque in budget. Scott S Suggested we move 100 into faculty awards budget. This was approved.
    - There was discussion about adding industry sponsorships into proposed budget. The group felt that this wasn't a good idea, so it was tabled. We need to make sure that those sources donating money are included in the conference program.
    - There was concern about not having an itemized breakfast budget for programming teams. It was decided that we won't need to provide that much food for student breakfasts, so the 0 will be left in that item.
    - Budget was approved as amended. This needs to be submitted at SIGCE board meeting
    - Tentative Call for papers deadline for 2013 conference was set as 12/3/2012. By setting the deadline now, it can be posted on the website and announced at SIGCSE
  - 3. 2014 conference, updates
    - Ed has looked at potential dates and April 4<sup>th</sup> /5<sup>th</sup> is best choice at Westminster.
  - 4. Discussion of conference sites 2015 and 2016
    - There is a tentative offer from College of the Ozarks
    - Rick will talk to faculty at Washburn
    - Northwest Missouri State faculty will discuss it and get back to us
    - Scott S mentioned that the further out we can schedule locations, the better off it is to help regional rep and potential attendees. Bob added that we need to make sure that commitment of site includes commitment from a chair at that site so that we have an assurance that the job will be completed.

- The online registration system is up and running, link is on website and active now.
  - NO PAPER REGISTRATION...credit card payment can be made through Paypal.
  - Those paying by check can still register online, but will need to pay on site at OTC.
  - There will be computers set up for registration on site as well.
  - The new system will allow members to manage their own contact information, address updates etc rather than having officers manage it.
  - Authors will need to register and then send checks to Paul Wiedemeier (sp?).
  - Programming team cost is PER TEAM not based on number of team members.
- Scott Sigman has accepted the nomination for VP Elect this coming CCSC cycle. If elected, we will need a new region representative (2 years left on his current term though the appointment would likely be for just 1 year). The CCSC president would

appoint a new representative. We might need to come up with names of possible nominees.
