- 1. NECC (Kevin appendix 11) It appears the relationship between CCSC and NECC may be ending. Kevin will continue to talk with ISTE/NECC to see if there might be a future. He will present a report Spring 2004 with a recommendation. (SIGSCE has decided against a relationship with NECC.)
- 2. Regional Bylaws Curt will see where we are with respect to regional bylaws (which region has not yet submitted regional bylaws) and will report on current status at the Spring 2004 board meeting.
- 3. Election Procedures Kris and Curt will consider procedures and will report at the Spring 2004 board meeting.
- 4. Organization Audit We need to approach an insurance company to see what is needed (auditwise and cost-wise) to get insurance bonding. Paul will look into it.

5. Database - The board will create a database committee, its purpose to be defined later in a draft from Paul. (Purpose could be 1. provide authority of the board rather than 1 person (Kris), and 2. consider options such as payment to Brent and professional registration company).

Board will consider some form of payment to Brent, and/or payment to Brent's student helpers. Committee will consist of Anne, Kris, Bill, Brent. Bill will be chair.

- 6. Conference Coordinator (Will appendix 12) Will presented status of Mid-south. They are going to continue on their own, separate from CCSC.
- 7. Paul created a task force to examine CCSC Growth Plan. Members include Myles, Will, John, and Nancy. Charge will be forthcoming from Paul and will reflect the issues presented in the agenda.
- 8. Paul created a task force to finish a revised set of bylaws for Spring 2004 board meeting. Members include Paul, Rob, Curt.

Straw vote: Should the consortium move to a 12-month calendar year: 7 in favor. Should consortium stay on current fiscal year schedule: 2 in favor. Paul asked Kris and Bill to work out the exact wording for this issue, to be presented to the bylaws task force.

Motion: The consortium support financially (as per our travel policy) each of the two task forces to meet face-to-face once, if needed, to address issues.

Richard: However, I am inclined to support policy that allows the use of our member lists to send information that is:

- clearly relevant to computer science and/or computer science education,
- likely or very likely to be of interest to CCSC members,
- from a non-profit organization.

Criteria for a link to be posted, a board member must sponsor it along with, if appropriate, a length of time to keep it. That will allow an avenue for things to reach the webmaster via some person acting in a "formal" duty of the board. Obviously, outdated/non-working links can be trashed as they are found.

7. Task-Force Creation

- A. <u>Bylaws</u> (Curt, Paul, Rob, ...)
 - -- the Bylaws should reflect regional concerns in a meaningful way.
- -- Kris: 1. Proposed *amendments* of these Bylaws may be submitted in writing to the President-Elect by any member of the Consortium. Proposed amendments will be presented to all members of the Board of Directors for consideration. All proposed amendments must be approved by the Board of Directors before being submitted to the membership; those approved by the Board shall distributed to the membership at least thirty (30) days in advance of the annual meeting of the Consortium.
- --Kris: Under Article III membership, we have: 7. The *membership year* for the Consortium shall correspond to its fiscal year. I would like to propose that this be changed to: 7. The membership year for each individual shall correspond to a calendar year, beginning on the date that their membership application is processed.
- -- Expansion of duties of the *Conference Coordinator*. It has occurred to me that this position is somewhat misnamed. The role has historically been that of conference creator and facilitator. Given the changes in the CCSC that have required a moratorium on growth and the creation of a task force (see 8B below), it is not clear how much additional conference creation needs to be done. And that that is to be done will require much more coordination with existing

conferences than in the past. I can envision new policies such as (and this is just a random example) "conferences within 300 miles of each other must occur in different semesters." In other words: Coordination! The Growth Plan must reflect policies of this sort, it seems; and, therefore, the Bylaws must emphasize these sorts of duties as well.

B. Growth Plan (Myles, Will, John, ...)

- -- ways in which the Board sees CCSC growing in future (Do we grow bigger regional conferences, or more regions? What's the desired size for each?)
 - -- determine procedures/policies for the creation of new regions
 - -- timing of contiguous conferences
 - -- need assessment governing the creation of new regions

Reno Minutes:

We recommend that CCSC develop a comprehensive growth plan. The plan should include consideration of all aspects of CCSC business including:

- Density of regions;
- Number of regions the organization would like to have;
- Number of regions the organization could handle;
- Workloads of impacted positions: editors, treasurer, etc.;
- Who's attending current conferences, number of presenters vs. non-presenters, etc.;
- Impact of neighboring regions; coordination of conferences;
- Budget considerations;
- Long range planning for CCSC.

Motion. (Myles McNally) The president is charged to form a Committee to develop a growth plan for CCSC. PASSED.

<u>NOTE</u>: I think that the Consortium should fully support the work of crucial committees such as these.

Personal comments to accompany my report.

ISSUES:

- 1. Implementing the DB using the proposed change to the bylaws regarding membership year definition should not cause anyone problems as we will only be "giving" extra membership time. So I think we should implement the DB using the new definition and work on getting the bylaws changed as appropriate. Until the DB is at a point of meeting our needs, I think it would be useful to have the DB manager working closer with the board members. Paul's idea of a DB committee might be the path to follow...
- 2. I would encourage the board to support the bylaws revision and growth plan efforts in terms of funding those that work on it to meet when needed. It will require face time. I am willing to serve an either or both efforts if more members are needed.
- 3. We should have a viable audit procedure in place. I think it would be worthwhile to have an assistant treasurer who runs it. Maybe we can get that effort done by funding airfare for the 2-3 people we normally support at the spring meeting? This will also help us obtain a backup person for the critical treasurer position.
- 4. A universal template for paper submission would be very helpful. Some of the regions have ones that work. John seems to like the South Central process. Let's pick one to make all the editing jobs easier. This includes making sure the system can be implemented by all the regions (national website hosted?)
- 5. Lastly, I quote from one of Paul's early emails about this fall's board meeting: "No one seems to think we have a particularly large agenda."

 Judging from the agenda Paul just sent his responses were limited.. As you can see from the submitted reports list there are a significant number of reports missing. This adds a significant amount of time to the meetings if members do not read these reports prior to the meeting. Most of the information is factual in nature and would be better digested in a pre-board meeting read.

 I would like to suggest that in the future, reports contain an "ISSUES" section at the bottom which would include topics the region would like the national board to address. These sections would then be the basis for building part of the board's meeting agenda. And of course we cannot read what we do not have.....

Appendix One: Bylaws for the CCSC Midwest Region

BY-LAWS

Consortium for Computing Sciences in Colleges: Midwest Region

ARTICLE I - Name and Object

The name of the organization shall be: Consortium for Computing Sciences in Colleges: Midwest Region. The object of the organization shall be to provide one yearly conference in the Midwest Region of the United States that will be supported by and endorsed by the constitution and by-laws of the Consortium for Computing Sciences in Colleges hereafter referred to as CCSC.

ARTICLE II -- Membership

Members will be those persons who are members of the Consortium for Computing in Small Colleges who have selected the Midwest Region as their region for purposes of CCSC Voting.

ARTICLE III -- Governing Body and Duties

The governing body of the Midwest Region will be known as the Steering Committee. The Steering Committee shall consist of

The Regional Representative to the Board of the CCSC (who chairs the Committee)

Five duly elected members

- o Regional Editor (who also serves in that role on the conference committee)
- o Regional Membership (who also serves in that role on the conference committee)
- o Regional Webmaster (who also serves in that role on the conference committee)
- o Two At-large Positions

The Current Conference Chair (who also serves as the Regional Treasurer)

The Previous Conference Chair (who also serves as the Regional Secretary)

The term of the regional representative will be determined by the bylaws of the CCSC. The term of office for the other elected members will be three years or the remaining time of a vacated office. Steering Committee members must be members of the Midwest Region. Elections for these positions will be staggered and will be held at the annual business meeting in conjunction with the regional conference.

The responsibilities of the Steering Committee will include selecting the site and date of each conference, selecting the conference chair and associate chair, preparing the annual budget, insuring the publication of the proceedings, holding regional elections, and preparing amendments to the conference bylaws and standing rules.

ARTICLE IV -- Meetings

The Midwest Region shall support one annual conference at which the Steering Committee will also meet. In addition, the Steering Committee shall also meet in conjunction with the spring planning meeting for the next conference.

ARTICLE V -- How to amend the by-laws.

These by-laws may be amended by following the rules for amending the constitution and by-laws of the CCSC.

ARTICLE VI -- Standing Rules

The Steering Committee may formulate standing rules to supplement these By-laws, so long as they are not inconsistent with these By-laws. Standing rules may be adopted by a two-thirds vote of a quorum of the Steering Committee at any regular meeting. Each Standing Rule adopted shall become an addendum to these By-laws.

Northeast Report Report from the CCSCNE to the CCSC Board

2003 Conference

The Eighth Annual NE conference was held at Rhode Island College in Providence, Rhode Island, April 25-26, 2003. It was another successful conference, with 169 regular (faculty) attendees, 31 programming teams, and 44 student posters.

There were 41 papers submitted of which 20 were accepted, thus giving an acceptance rate of 49%. There were four panels submitted with four accepted, five tutorials submitted with three accepted (though one of the accepted tutorials – the one from NSF, no less – failed to show up), and five workshops submitted with two accepted as workshops and a further one accepted as another tutorial

Students posters were displayed and judged mostly during the social hours. The three best-paper awards (in the amounts of \$150, \$100, and \$50) were given at the Saturday lunch, which marked the end of the conference.

There were two excellent plenary sessions: John H. Conway (John von Neumann Distinguished Professor of Mathematics, Princeton University) and Linda Stern (University of Melbourne, Australia).

There were four sponsors, who helped make the conference possible:

- Microsoft Corporation gave a grant to help defray the costs of providing an affordable conference at the regional level, to support of the Programming Contest and the poster contest.

- 2. Since our last meeting in Reno, the following noteworthy matters have been dealt with or have arisen at CCSCNE:
 - 1. Online submission for processes have been greatly improved.
 - The membership chair Danny was charged with adding the email addresses of all chairs of computer science departments at institutions likely to be interested in CCSC within our region.
 - Conference registration into the database was done locally.
 - 4. There is a possibility that a one-time contribution of as much as \$5000 might be made for the 2004 conference. The board is reluctant to set higher prize moneys or to lower the conference fee because they could not be continued in future conferences. There are no firm plans at present as to how such money might be spent.

Other regional board members are Julia Benson (membership chair), Susan Dean (publicity, UMUC – Maryland in Europe), Dee Medley (treasurer, Augusta State University), Kris Powers (local registrar, Berry College), Bill Myers (at-large, Belmont Abbey College), Becky Tallon (secretary, Lipscomb University), John Meinke (Proceedings Editor, UMUC – Maryland in Europe), Joe Sloan (2004 site co-chair, Wofford College), David Sykes (2004 site co-chair, Wofford College), and Paula Gabbert (2002 site co-chair, Furman University).

For the first time in 2003, the Southeastern region mandated that a local conference committee be formed. The members of that committee are:

The scheduled program includes 26 regular papers, 7 student papers, 1 panel, and 3 tutorials/workshops. A total of 38 regular papers were submitted of which 16 were accepted outright, 10 accepted conditionally, and 12 rejected (acceptance rate 68.4%). 11 student papers were submitted with 4 accepted, 3 conditionally accepted, and 4 rejected.

A pre-conference workshop entitled "Human-Computer Interaction in the Classroom," will be presented by Daniel D. McCracken of City College of New York (scheduled from 9 a.m. to noon on Friday, November 7).

Dr. Amy S. Bruckman of Georgia Tech will give the keynote address "Learning in Online Communities." Dr. Irfan Essa of Georgia Tech will give the banquet address "Digital Video Special Effects, a Computer Science Perspective". For the first time this year there will also be a luncheon speaker, Dr. Mark Guzdial of Georgia Tech, on the

topic "Introduction to Media Computation: A new CS1 approach that addresses women's interests".

Student activities consist of a programming contest, a web design contest, and a student paper contest. A maximum of 25 teams is expected to register for our 10th annual programming contest. 2 teams submitted entries to our 2nd annual Web Design contest, and (as noted above) 7 student papers will be presented. Winners in each of the competitions will be announced at the conclusion of the conference on Saturday, Nov 8. Web contest awards are funded through the UPE grant.

2004 CCSC: Southeastern Conference

Other Regional Issues/Activities

The fourteenth annual CCSC South Central Conference was hosted by Millsaps College in Jackson, Mississippi April 11-12, 2003. The conference was chaired by R.W. McCarley. There were 52 participants of which 3 were student attendees. The keynote speaker was Kerry McKelvey, CEO for Skytel Communications Broadband Wireless Access. APPENDIX 11: NECC REPORT

NECC REPRESENTATIVE REPORT November 6, 2003

Background

For over ten years, CCSC has held "cooperating professional society" status with the National Educational Computing Association (NECA). Benefits of this association included:

the opportunity to help plan the annual National Educational Computing Conference (NECC)

the opportunity to present an annual panel discussion as a NECC "society session" at the conference

the inclusion of the option to choose CCSC membership on the NECC registration form the opportunity to have a booth advertising CCSC at NECC

the opportunity to submit proposals to the NECA Special and Collaborative Projects Grants Program

There was no cost to CCSC other than the cost of sending the NECC representative to the biannual meetings of the NECA board.

Two years ago, NECA merged with the International Society for Technology in Education (ISTE). That began a process of re-assessing and re-writing the organization's constitution and by-laws. The question of what to do about cooperating societies was left to a task force that deliberated for quite a while.

Currently

CCSC sponsored the society session "Encouraging and Keeping Female Students Interested in Technology" (presented by Paula Gabbert of Furman University and Suzanne Hoffman of the Sanford School) at the 2003 NECC conference in Seattle in June.

And in June the task force also reported its decision -- to do away with a formal structure for cooperating societies altogether. Instead, organizations have the option to explore custom-designed partnerships with ISTE if they so choose. CCSC has been officially invited to do so.

Future

It is questionable -- without having a conversation with ISTE -- how much benefit a continued partnership would be to CCSC. NECC has evolved into an almost exclusively K-12 conference. It is, however, a conference with as many as 15,000 attendees annually, so the visibility alone makes it worth looking into. I would recommend that the NECC representative have a conversation with the appropriate ISTE officials to find out what kind of partnership might be possible. It is important to note that there is likely to be a fee involved.

APPENDIX 12: CONFERENCE COORDINATOR REPORT

Conference Coordinator's Report to the CCSC Board
Fall 2003
William Mitchell

Observing the moratorium on new conference formation while the Growth Committee reaches a recommendation, the coordinator's activities have been limited to insuring the successful execution of the first Mid-South Conference and the archiving of excess proceedings.

That being my report, I must explain that it is early due to the fact that an unwarranted ruckus has been raised by the Second Mid-South College Computing Conference. This is a separately incorporated non-profit corporation that produces an annual conference for computing faculty in the vicinity of Memphis, TN. There is a connection to CCSC in that CCSC sponsored the creation of this conference and provided services, including web services, mailing lists, publication services and financial services to the first conference. It was my understanding that this was done under the terms of our non-profit, public benefit incorporation charter in which we declared as our reason for existence "to promote the betterment of computer-oriented curricula in two- and four-year colleges; to improve the use of computing as an educational resource for all disciplines; and to promote a national liaison among the several local and/or regional organizations devoted to this purpose." It is my belief that we all recognize the benefit of regional conferences and while we cannot afford to sponsor an unlimited number, we would certainly not impede or discourage those who feel the need to participate. There used to be an annual faculty conference in Arkansas supported by Acxiom corporation but due to cutbacks, this conference has been defunct for several years. The Mid-South is filling that void for many Arkansas faculty.

The steering committee of the Mid-South has difficulty understanding why CCSC Board members feel they have the sole right to franchise the country. Eastern got along just fine without the CCSC, even after the CCSC "moved into their territory" by sponsoring the Northeast and the CCSC stopped distributing their proceedings. The Small College Computing Symposium in the upper Midwest does not complain that CCSC created the Central Plains conference or when Rocky Mountain held a conference in South Dakota. The regional conferences exist to meet a demonstrated need—CCSC has created new conferences whenever a viable number of faculty indicated that they would support the conference. These same faculty may also support other conferences (we see this a lot between Eastern and Northeastern). The problem is that there is more felt need for regional conferences than CCSC has resources. We have taken as our mission the promotion of regional collaboration, but we are not obligated to sponsor and support more conferences than our resources allow. If new conferences can prosper without our assistance or with minimal assistance, we should be glad. This is not a zero-sum game.

CCSC has several new board members, so I would like to lay out the record of the Mid-South College Computing Conference and point out why the CCSC should be a good neighbor. I and Bill Myers explained to the Mid-South steering committee that CCSC would not sponsor a second conference because it might have reached the limit of its growth or would prefer to direct it resources to other needs. The committee decided that since CCSC could not meet its felt need for convenient access to an annual meeting, that it would continue independently, grateful for the help CCSC was able to provide. Nevertheless, the incorporation charter specifies that should the Mid-South College Computing Conference vote to dissolve the corporation, all of its assets would be donated to CCSC. We would certainly want the Mid-South to build up a nice nest egg and then give it to us. We would certainly want faculty from our schools or others (67% of Mid-South's first conference had never attended a CCSC conference) to enjoy the fellowship and education that we enjoy in regional conferences. Mid-South has built into its conference fee a membership in CCSC (something we never convinced Eastern to do). Therefore 30 to 40 faculty will renew every year without the requirement of attending a (distant) CCSC conference that they never were motivated to attend before. Now some may even be motivated! We have certainly helped ourselves by helping these faculty form an organization that they can conveniently support.

I am dismayed by the tone of the complaints that have been circulated concerning this good work. The attitude is that its just too bad that faculty in Memphis can't take the trouble to fly to Austin or Atlanta to attend a conference. It seems that people forget that the conferences were created so that people could carpool and arrive in half-a-day's drive. When regions are large, faculty with small travel budgets attend less frequently, and in the case of Memphis a CCSC conference has come within a 4 hour drive only once each 5 years. Yet I hear the muttering "better that they attend my conference every three years than not at all." There is no prize for large conferences. Rocky Mountain has never grown and it is smaller than all the others and it is still hanging in. All the conferences have a loyal support base large enough to make them viable. There is no basis for trying to penalize faculty would like to be able to afford to drive to a conference every year.

I am also dismayed by the continued allegations that the Mid-South was created illegitimately. Carl last fall in moving that we suspend formation of new conferences admitted that all existing procedures were following in creating the Mid-South—he just didn't think the procedures in place were proper. Since not everyone has time to read the old minutes, I attach an appendix to document the steps in the conference's formation. The Exhibits are in reverse chronological order, moving from the call for the second conference that was distributed using the mailing list that we assembled for the first conference, back through the reports that I gave to the board at each step, to the original solicitation to form a steering committee, outlining the CCSC requirements for sponsorship. You will find dated emails in which the officers and board were constantly informed and had the privilege of stepping in and halting the process up until the steering committee accepted the conditions of sponsorship. Nothing was done in secret and everything was done in the formation of Mid-South that was done for the formation of Northeast.

In summary, this report argues:

1. In helping to launch the Mid-South College Computing Conference the CCSC was following it purpose for existence.

- 2. It is to the benefit of the CCSC to encourage the Mid-South College Computing Conference because the first conference proved there was an unmet need that is now being met. It costs us nothing and serves computer educators in the region to put a link on our website that the Mid-South College Computing Conference is no longer affiliated with the CCSC, and points to www.msccc.net. The more faculty that attend Mid-South, the more memberships CCSC receives.
- 3. There is no evidence that the Mid-South decreases the attendance of any other CCSC conference. It will move to Oxford, MS next year, likely Monroe, LA, or Martin, TN in 2006. It will not be within 400 miles of any CCSC conference in the next few years.
- 4. The conference was legitimately created following all the procedures established by the CCSC Board. The Board has since rescinded those procedures.
- 5. It makes no sense to take offense at the Mid-South College Computing Conference. The Board should be spending its energies on finding ways to assist the Mid-South and to continue to expand the CCSC's ability to promote regional collaboration of computing faculty. We do not want the reputation that we try to undercut those we disagree with. The Mid-South is independent not by choice but by the failure of the CCSC to grow its support resources. Once it is known that CCSC has reached its limit, the door is open for SIGCSE or SCCS or MSCCC Inc., to step in and build a parallel organization to fill the gap. With the growth of IT there is room for several more regional conferences (I am on a committee to start a software engineering conference and we have started two regional research conferences here in Little Rock the past two years).

Spring 2003 CCSC Board Meeting

Report of the Conference Coordinator William Mitchell

Per Board action, no efforts have been made to organize additional conferences since the last report.

The MidSouth conference has produced a program and distributed its call for participation. It accepted 21 or 26 submitted papers after a blind refereeing process and structured 7 paper sessions, 2 pre-conference workshops, a post-conference workshop, 6 tutorial sessions, one panel, and one BOF session to fill three tracks. There are 32 authors and committee members who will register and so far seven additional registrations have been received. Of these only three are current consortium members.

The University of Mississippi has two members on the steering committee and that institution provided four papers and a tutorial. UALR had two members on the steering committee (counting me), and that institution provided 2 papers, a panel, and a BOF session. UL at Monroe had one steering committee member and that institution provided two workshops, two papers and one tutorial. Presenters farther than 200 miles from Memphis were two papers from Pittsburg State University (CP), a paper from West Texas A&M, a paper and tutorial from UT Tyler, a paper from Centenary of Louisiana, and a paper from Southeastern Louisiana (SC), a paper from University of So. Alabama, and a tutorial and a panel from NCSI.

The committee has not settled on a keynote nor its slate of vendors, but it will include those in a second call for participation to be mailed the first of March.

The steering committee intends to plan a second conference. I have informed them that CCSC has not committed to sponsoring a second conference. This produces a novel situation where CCSC has started a conference and set it free instead of building a region around it, hence creating a situation identical to that of the first 20 years of the Eastern Small College Computing Conference. The steering committee desires that each of its attendees join CCSC for 2003-2004 and will forward \$40 of its \$120 registration fee and a membership application for that purpose. Further, the steering committee will reimburse CCSC for any start-up expenses that CCSC has incurred in its behalf. I propose to hold the remainder of the MidSouth funds in an agency account at UALR once the conference is disassociated from CCSC, awaiting the time when CCSC will be able to expand. I will continue to keep the Board informed of the places and times of the future conferences. It is likely that if the Journal is not interested in distributing the conference papers to the CCSC membership, the next conference will publish its proceedings on CD.

Report of the Conference Coordinator to the Fall 2002 Board Meeting of the Consortium for Computing Sciences in Colleges William Mitchell

- A. Progress of the initial MidSouth Conference. Attached is the first call for this conference. The second call for papers is going out this week to nearly 500 individuals. The mailing list began with CCSC members in the region combined with at list of IT faculty maintained by the Business College at the University of Mississippi. The website is present on the CCSC server (http://www.ccsc.org/midsouth) and at Rhodes College (http://www.mathcs.rhodes.edu/~ms). The Vendors chair is working on bringing in vendors (Memphis has many possibilities) and is to contact the national committee to determine the potential for having national vendors present (because this is an experimental conference, it is not promised to national vendors). The paper submission deadline is December 6, so no papers have been received to date, but several promises have been received. Only one panel has semi-officially submitted but the panels chair hopes to have a couple of others. The Student Activities committee is working on details for the logo contest and student participation. The French Quarter Inn on Overton Square has quoted us a \$59 per night conference rate. The Steering Committee continues to be enthusiastic about the prospects for a successful conference and a new region.
- **B.** The Board's Standing Rules commit the CCSC to supporting the initial conference once the Steering Committee has been formed and accepted the conditions imposed on conferences by the Board. The CCSC will publish the conference proceedings as an issue of the Journal as a consequence of the refereeing processes being followed. However, the Board needs to approve the proposed conference budget (attached), and the Board may wish to stipulate any conditions that must be met to continue under CCSC sponsorship and to join the CCSC as a new region. Taking these matters serially, **I move that the proposed budget be approved.**
- C. As Conference Coordinator my role is to support existing conferences and to organize new ones. As presented to the last board meeting, a Memphis area conference has been in the making for several years, and I believe that a MidAmerica region is feasible in another few years. I think that with the addition of Eastern we have begun to downplay the role of state boundaries in describing a region (at least in terms of a partition). Eastern overlaps both NE and SE. I describe MidSouth as 200 mile radius around Memphis. It will pick up western TN and KY, northern AL and MS, Northeastern LA, the eastern half of Arkansas, the SE of Missouri, and southern IL. St. Louis area remains on the border between CP, MW, and MS, and the Columbus, Cleveland, Pittsburgh, Charlestown, WV quadrilateral is un-served by CCSC (the potential MidAmerica region). I would describe SE as a 300 mile radius of Chattanooga and SC as a 300 mile radius of Austin even though they have gone to Oklahoma City once and Jackson, Mississippi twice in thirteen years. NE seems to attract within 150 miles of Boston, and Eastern within 150 miles of Scranton (where it began). Northwest was carved out of Rocky Mountain, but actually RM doesn't reach across the Rockies in the same way that neither SE or SC ever reached Memphis. There are a dozen institutions of higher education teaching computing within the Memphis city limits, and only three of the private ones are on the MidSouth steering committee (but we will recruit the others). I therefore believe that MidSouth will make a very viable region and will have minimal overlap with its neighbors (it might win attendees from central Mississippi, but only when the conference goes south of Memphis). I move that the Board evaluate the progress of MidSouth at the next meeting in Reno and at that time specify conditions for forming a new region.

Here is what you wanted.

At the Spring Board Meeting on March 1, 1995 at the Opryland Hotel in Nashville, the Board discussed the report of the growth committee chaired by John Rabung "CCSC--Strategies for Managing a Growing Organization." That report had a section (I. B) concerning new conferences. I quote from the Minutes: "The report suggested that a budget for new conferences be solicited before approval from the board. It was suggested that this was asking too much, since even after the effort was expended the board could still refuse to give approval. Sue Fitzgerald suggest that it simply be stated that the board "must approve" all new conferences, with no specific requirements given. Will Mitchell then moved that the New England conference be approved. Paul Haiduk seconded and the motion was approved with one nay vote and one abstention."

Since that time the process for creating new conferences has been that the Conference Coordinator informs the Board of the intent to seek a new conference (for a while I was asked what I was doing to galvanize interest), the Conference Coordinator informs the Board when an organizing committee is preparing to meet. The Conference Coordinator informs the Board whether the organizing committee agreed to plan and produce a conference according to CCSC policies. The Conference Coordinator represents the initial conference committee to the Board until the first conference is successfully held. At that meeting the attendees vote on continuing the conference and petitioning CCSC to be recognized as a region, electing their own representative. The Board then decides to accept or reject the petition.

The Board has the option to deny the Conference Coordinator permission to convene an organizing committee, but once the committee meets and agrees to the terms under which CCSC conducts conferences, the Board must allow the initial conference. The Board may as a consequence of the response to the conference either not receive a petition to become a region (whence no further conferences by the original organization will be sponsored—the organization may fold or prefer to go independent), deny the petition (whence the organization may fold or go independent), or accept a representative from the new region as a board member. Northwest has been the only region started after this policy and Chuck Howerton actually did the Conference Coordinator job instead of me.

As far as the Mid-South region is concerned, the Board was fully informed of the intent to try to form the region and was given advance notice of the April 20 organizing meeting. In the absence of Board action, the above quoted policy applies and the next opportunity for Board action will occur at the fall 2003 Board meeting when it is likely a petition will be presented.

SPRING 2002 CCSC BOARD MEETING

Report to the Board of CCSC on Formation of the Mid-South Region William Mitchell, Conference Coordinator

I would like to share with the Board the level of interest that I have received in my second try to form a steering committee for a new region in the mid-south. I will present a motion to the Board to approve the exploratory meeting on April 20 at Christian Brothers University in Memphis and the recognition of a new region should they decide to organize a regional conference for the spring of 2003.

There are obviously preparations that the Consortium must make to add a new region. The first is adjust the workload on the Editor (and on the Registrar). We did not try to DECREASE the number of conferences so that one volunteer registrar could handle the load, instead we have spent most of this year debating how we can reorganize how the Consortium operates to handle the requirements of growth. We may have to spend part of next year helping the Editor prepare for a greater workload.

The second is the impact that a new region will have on existing regions. I have 10 institutions that have volunteered representatives to serve on the steering committee. It is apparent that many of these institutions have never sent either a presenter or attendee to one of our conferences and the non-involvement of these schools is the reason for starting the region. The remaining volunteers are enthused about ONE past encounter, indicating that while they enjoyed the experience, they did not feel a part of the region they attended, principally because the region conference only came into their geographic area infrequently. The folks at Millsaps have flown to South Central conferences for years and have been rewarded now with the hosting of a second conference (I visited with Dr. McCarley three years ago about starting a new region and he said that he'd have to fly up to Missouri, so he'd just as soon fly to Texas). Other Mississippi schools will come when the conference is in Mississippi, every five years (3 Mississippi colleges and 4 Louisiana colleges sent presenters to the 1998 conference in Millsaps (10 of 31 presentations). Only 6 presenters came from those Mississippi Colleges in the next three SC conferences and 5 from the Louisiana colleges (out of 110 presenters). For some of these schools it will still be shorter for them to drive to Texas than to Memphis. UALR will go to the Mid-South region instead of Central Plains or South Central, given the new alternative. We are about as far west in Arkansas as will be affected.

Subject: Starting a new computer conference for the lower Mississippi region

Most of the faculty receiving this letter have had some contact with the Consortium for Computing in Small Colleges (soon to change its name to something like the Consortium for Computing Science in Colleges)[browse www.ccsc.org]. Some have attended our regional conferences, the most recent having been held in Nashville last November (the SE region) at David Lipscomb University. I am the founder of the consortium and the board member charged with developing new regional conferences. The SE region has never ventured west of Nashville. We have a Central Plains region that serves schools in a band along the Missouri and Kansas borders, and a Southwestern region that pretty much stays in Texas. For several years I have thought that there were enough faculty along the Mississippi to support a conference that would draw from the Delta (Cape Girardeau to Jackson, MS, Nashville to Little Rock). I have collected your names and would like to have you reply if you would like to see an annual spring conference for computer educators (business, science, and engineering, two and four year programs-oriented along the lines of ACM's SIGCSE). The CCSC is now in its 19th year and sponsors 5 fall conferences and three spring conferences, publishing the presented papers in the refereed Journal of Computing in Small Colleges. Our mission is to support computing educators through the publishing and

networking that occurs at our inexpensive regional conferences (attendee expense: registration, transportation, meals and hotel less than \$300).

If enough of you reply with the commitment that you or a colleague at your school would be willing to participate, I will arrange a planning meeting in Memphis later this spring. There is no financial risk in starting a conference since the CCSC pays all the bills, and it does not take a lot of work or resources. It can be very effective with as few as 30 participants. It does require an active conference committee and faculty who will present papers, workshops, and panels. The Conference would be scheduled on a Friday afternoon and Saturday morning, so that participants could drive in Friday morning and home Saturday afternoon, probably the last weekend in March of 2003.

Please respond to me if (1) you think this is a good idea and you would come to the Conference if we create it;

- (2) you think this is a good idea and you would like to serve on the steering committee (meet in Memphis)
- (3) you think this is a good idea and you would like to volunteer a colleague to serve on the steering committee.

The total membership appears to have fallen slightly from its total of 643 last year. We do, however, have some data difficulties, and so membership can be surmised as constant.

II. Transfer to new membership database system

Transfer of membership data to new database was accomplished for the membership year beginning August 1, 2003. At that time the old system was discontinued, and the data from that system was imported into the new system (with an archive kept for any future needs). The data has since been cleaned by examining the records by hand, and looking for inconsistencies and/or duplication. Both member and institutional data have been thus cleaned. The new data is in the now in the hands of the data base administrator waiting to be imported.

III. Regional registration

Regional registration was undertaken by NE in the spring as well as RM and MW in the fall (with the other regions still relying on national administration). The NE conference had significant bookkeeping difficulties in the spring, probably due to the larger size of the conference. Both NW and RM reported smooth experiences. In the interim between the fall and spring conferences, regional administration procedures will be reviewed and updated. All spring conferences will be encouraged to undertake local registrations.

JOURNAL ISSUES:

During calendar year 2003 we prepared conference proceedings for nine (9) conferences which were published in six (6) issues of the *Journal*. The following table summarizes submission details in final printed form for each of the nine conferences:

Notes:

- 1. These figures are hand-counted. Thus, there may be some "off-by-one" errors. However, they can be regarded as reflecting the general characteristics of each conference.
- 2. The columns under "Other" include: panel discussions, tutorial presentations, workshops, invited speakers anything other than refereed papers. (Note that the student poster presentation abstracts for Northeastern are not included in "Other" nor are the student authors for those abstracts included in the "Submitters" figures. They are reflected in the "Text Pages" count, though.)
- 3. The "Text pages" count does not reflect "extra pages" which include the title page, the copyright page, the table of contents (which can be as high as eight pages), the Board Roster, the roster of CCSC Corporate Sponsors, the Foreword, and the individual conference leader pages including the conference welcome message, the regional steering committee roster, the conference committee roster, the roster of referees, and the roster of session moderators. Thus, the total text page count does not accurately reflect the page counts of the individual *Journal* issues

Issues:

- 1. Paper page count limitations: This issue is not getting back to the individual conferences. In addition, frequently the conference contact for preparation of manuscripts to forward to the publications chair isn't known by me until well after the paper acceptances have already been transmitted to the authors and the authors are already preparing final manuscript. The winning page count was from Midwestern – 21 pages when final formatting was accomplished. Rocky Mountain had an 18 page paper, Southeastern had a 17 page paper as well as two 14 page papers, and Central Plains had a 17 page paper, a 15 page paper, and a 14 page paper. 13 page papers were included in Northwestern (2 papers), Eastern (4 papers), Rocky Mountain, Northeastern (2 papers), and Central Plains (2 papers). I feel that we need to establish clearly through the conferences that the maximum length is ten pages - at that point we can accommodate several papers that go over, but we can simply refuse to print a paper that is anywhere over 14 or 15 pages – the maximum guideline is there! (Note that the copyright notice takes up space on the first page, and frequently also causes a page break to occur early – the abstract leaves not enough room so that an orphan/widow occurs on the first page – thus we may end up adding a page to the author's final submission.) However, that maximum page length MUST be communicated from the individual conference – it really needs to be included in the call for papers!
- 2. Issue page count limitations: We need to watch these very carefully! I have in the past used a 400 page limitation for bulk mailings based on past experience. Last December's bulk mailing consisted of a Journal issue that was 368 pages of text plus 12 leader pages for a total of 380 pages. We included a three sheet newsletter which would be equivalent to about 12 pages of regular text, so that brought the "page count" to 392. The mailing weighed in at exactly 16 ounces on the Muhlenberg College scales, the limit for bulk mailings, and when it was weighed by the US Postal Service scales it came to 0.9965 pounds 0.0035 lbs. off the limit that's a bit too tight for me to deal with! (For those on the Board unfamiliar with the issue, it was several years ago that we had an issue of the Journal exceed the one pound bulk mailing weight

limitation, and the only alternative was to pay first class postage for the mailing, a significant impact on our treasury!)

3. Combined conference proceedings: Page counts caused some real problems with the Fall conferences. Both Eastern and Southeastern went significantly over the roughly 200 pages of text guideline, posing problems with combined Journal issues. Midwestern and Rocky Mountain went together fine, but then there were problems combining with Northwestern since either Eastern or Southeastern would exceed the page limit. The decision was to let Southeastern be the stand-alone, since it was the largest, and move three 13 page papers from Eastern into the previous issue. (While they would not appear within the same issue, they would be available to the attendees at Eastern since all attendees become members, and in the past the previous issues have been available at the conference.) That decision was made based on the cost of completely separate issues for each of Northeastern, Eastern, and Southeastern.

We need to seriously look at the combined issue situation. Examining the above table, the "problem" conferences did not have an average length paper page count extremely out of line. Rather, the problem was the number of papers that were accepted. (While we do have the long paper offenders, overall it appears to wash out to a reasonable average for each conference. Note, though, that South Central has been very clear on page count problems to their authors, and their average is a full two pages less!) I don't believe that the Consortium Board wants to seriously impact the flavour of any of the conferences by limiting the number of accepted papers – rather, we should be encouraging an increase in the number of quality accepted papers. Thus, we may face more additional issues of the Journal, and should accept that increased cost.

Overall, we see from the final two columns of the table that there is a roughly ten page increase for many of the conferences. I expect that that increase will probably be something that we see in general, particularly as we see more and more graphics in the manuscripts.

At this point I anticipate that over the next year our printing costs will go up as we face more and more pages of copy for each conference, and must be prepared to print separate proceedings for each conference.

NEWSLETTER:

We printed newsletters in January, February, and June for inserts with the Journal, a well as the stand-alone issue in September. The December bulk mailing caused me to exercise a bit of restraint in including newsletters in each issue due to the bulk mail weight limitation problem and coming so very close in that mailing.

ACM:

I supply the pdf format for each of the papers to ACM for posting to the Digital Archives, and as far as I know that is going well. At this point the pdf for the individual papers for the first three issues of Volume 19 have been supplied to ACM, and ACM has been asked to "move slowly" on the Southeastern papers – waiting until after the conference to post them to the Digital Archives.

I received an inquiry from ACM during the summer for Volume 6 Number 5, and assumed that it was a typo, that they really meant Volume 16 Number 5, and responded that in that particular volume there were only four issues. No, it was the Spring 1991 issue (South Central). My wife

was able to find the floppies, forward them to me, and I was able to recreate the pdf, and within 24 hours of when it was forwarded to ACM it was available on the Digital Archives. It's interesting to note that that particular conference had 13 papers comprising 97 pages of text for an average of 7.62 pages per paper, and 8 panels/tutorials/workshops comprising 11 pages of text for an average of 1.38 pages per "abstract". The longest paper when reformatted to our current format was 12 pages, with 3 papers at 10 pages. Three were 42 people listed as authors/co-authors/discussants

MANUSCRIPT CHANGES PLANNED:

As a result of some recommendations, several changes are planned for future manuscripts:

- 1. Drop titles of authors in the table of contents. I have included, in the past, whatever was submitted by the authors. I have received feedback that they create discrepancies in the table of contents.
- 2. Include whether a session is a panel session, tutorial, workshop, whatever, in the table of contents.
- 3. There are no "hard and fast" planned changes in manuscript submissions. There was a recommendation that we accept pdf format. However, it is very difficult at this time to extract from pdf, and the figures present more problems than solutions. I have asked that I receive either a hard copy or a pdf copy so that I know what the author originally intended. That is not happening, so I'm still flying blind on what the author expected the final copy to look like. A suggestion was that we provide a set of templates, WordPerfect and Word, such as what ACM currently provides. I see that as a possibility, but requiring very careful preparation of the template. It's very interesting how submitters can go as awry as they do when following what one considers specific guidelines.

Northwestern is currently exploring the possibility of submitting on-line with the tested and proven package prepared by South Central. While that package proved to be wonderful last year I'm hearing more problems from Northwestern regarding being able to implement that tool. In the last year I must say that South Central was the easiest conference to work with in preparation of final manuscripts.

4. Copyright releases continue to be a problem. One conference, Rocky Mountain, apparently did not send copyright releases to the authors until I inquired of the status of the copyright releases – all of a sudden there was a mad scramble to obtain copyright releases from authors and the final manuscript sat waiting until that would be accomplished. The copyright releases are essential due to publication to the ACM Digital Archives.

MAILING ISSUES:

A problem that has surfaced this Fall is obtaining mailing labels for the Journal. There appear to be two issues impacting the production of the mailing labels: (1) the integrity of the data, at which point printing mailing labels with bad data is pointless; and (2) apparently the mailing labels could not be made available from the database at that point, so the effort was to resolve the data integrity problem and then address the mailing label issue. In the meantime, the September Newsletters sat until George Benjamin decided to use the mailing labels from the June mailing, and at least got them out! In the meantime, I had authorized the posting of the October issue of

the *Journal* at the end of September, which at the time of the release could not be accomplished due to the mailing labels not being available.

From a publications perspective we have a very serious problem here. The membership benefits includes **mandatorily** the *Journal*, and it appears that at this point we do not have a mechanism to get the *Journal* to the membership! We need immediate answers to two questions:

- 1. What is being done to accomplish database integrity, and when will it be accomplished? We need an immediate answer on that, and if the answer is not acceptable we need to take steps immediately to resolve that issue.
- 2. What is being done to resolve the mailing label issue, and when will that be accomplished? Again, we have an obligation to the membership which must be met. The Board committed to the new database being established by a formal database administrator and it appears that the expectations have not been met. The Board has a legal commitment to the membership, which is binding.
